#### APPROVAL OF AGENDA

Under personnel, the Board approved Andrew Focht as a Volunteer Coach and Jenna Ramsey as a Classroom Volunteer.

#### SUPERINTENDENT UPDATE

There was discussion on proposed School Board meeting agenda modifications. President McDonald presented suggestions to the Board. Suggestions included adding the following items periodically: hiring and retention of staff members, learning opportunities for Board members, community engagement, and good news presented by students and staff. He also suggested that facility updates and transportation updates be placed periodically rather than monthly.

Motion by Tibben, second by Ward to approve School Board Policies 106.1, 501.12 and 708. All in favor. Motion passed.
